ARMORER'S COURSE

The Winchester Police Department will be hosting a two day AR-15 Armorer's Course approved by the Kentucky Law Enforcement Council.

Attendees' will be eligible to receive 16 hours of KLEC credit for attending and passing the course.

Training will be conducted by Instructor Don Alwes, Jesse Starnes of Double Star Rifles, and armorer's from Double Star Corp.

Course Description: This course is designed to provide the law enforcement armorer with knowledge and skills necessary to maintain the AR-15 type weapon system in areas to include nomenclature, field stripping, complete disassembly and assembly, cycle of operation, function inspection, cleaning, lubrication, trouble-shooting, accessory selection and installation, and use of special tools.


